



defense counsel stated, in part, “attached please find the Order entered by Judge Donnelly this morning in connection with the above matter.” The attachment filename reflected in defense counsel’s email was “Scan\_John\_O\_Connor\_11\_55\_41,” indicating that defense counsel personally scanned the signed order at approximately 11:55 a.m. — while Plaintiff was no longer present in the courthouse. A true and correct copy of the email from defense counsel is attached hereto as **Exhibit A**.

5. Prior to receiving the email from defense counsel, Plaintiff had not received, reviewed, or otherwise been provided a copy of the signed order by the Court.

6. Plaintiff contemporaneously contacted Calendar W at 2:30 p.m. regarding the transmission of the order, advising that Plaintiff had received a copy from defense counsel but had not been contemporaneously served by the Court, and requested inclusion in service and correspondence pursuant to Illinois Supreme Court Rule 11. A true and correct copy of Plaintiff’s email to Calendar W is attached hereto as **Exhibit B**.

7. Thereafter, at 2:58 p.m., Calendar W responded, in part, that “[t]he court has not sent out the electronic version of the order,” and subsequently transmitted the stamped order to the parties. Calendar W’s response confirmed that defense counsel’s transmission of the signed order to Plaintiff preceded the Court’s own official electronic dissemination. A true and correct copy of Calendar W’s response is attached hereto as **Exhibit C**.


